

LEGAL BASIS FOR PARTICIPATION IN THE DRAW

1.- ORGANIZING COMPANY

The company PRODUCTOS DEPORTIVOS SA (LAKEN) with address at Polígono Industrial Oeste, Av. Principal, Manzana 25 (30169 - San Ginés - Murcia) and identification number A30019525 organizes for promotional purposes the draw "Julio Sin Plástico 2021" (hereinafter, "the Promotion") of national scope, to be developed through Instagram (Internet), exclusively for users residing in Spain (except Ceuta and Melilla) and of legal age in accordance with the provisions of the section on conditions for participation.

2.- START AND END DATE

The Promotion will start on July, 21st, 2021, and will end on July, 29th, 2021, 11:59 p.m. The winners of the draw will be announced on July, 30th, 2021.

3.- PARTICIPATION REQUIREMENTS AND MECHANICS OF THE PROMOTION

The participation requirements are as follows:

- Only people residing in Spain (including the Canary and Balearic Islands and excluding Ceuta and Melilla) and over 18 years of age may participate.
- Only those participants who meet the two requirements set out in the previous point and complete the mechanics of the Promotion will be able to participate.

Mechanics of the Promotion:

To participate in the Promotion all the following points must be fulfilled:

1. Follow @laken_bottles account on Instagram
2. Follow @tutete account on Instagram
3. Like the main post of the draw (not stories) made on @laken_bottles or @tutete profiles
4. Comment on the same post that has been liked by mentioning a friend

The more comments made on one of the main posts of the draw (on @laken_bottles or @tutete profiles), always mentioning different friends who might be interested in the products, the more chances of winning, up to a maximum of 5 participations per person.
